

NDS REGISTRATION & Conduct Agreement 2022-2023

*Dress Code:

NO jewelry of any kind (earring studs are fine) ALL hair MUST be ***completely*** pulled back for class. Tights and Leotards MUST always be worn. NO bare feet. Any shorts need to be form fitting and No baggy shirts or shorts are allowed during class. For winter long sleeve leotards are recommended.

All Shoes MUST be purchased from NDS to ensure proper Fit, Color, & Style for each class.

*Payment Info. & Late Fee's

\$50 reg. fee is due with registration form.

-9 Monthly payments are then due the 15th of each month Aug. thru April.

-3 Tri-season payments are due Aug. 15th, Nov. 15th and Feb. 15th

-1st half costume fee will be due Sept. 15th & 2nd half will be due Oct. 15th (both are non-refundable)

Costumes will be ordered October 15th, anyone paying costume fee's after this date is not guaranteed a costume and an extra \$10 shipping fee will be added. Make Checks payable to: Nikki McCuen & Write your dancers name & class name in the memo. Separate checks for each dancer please.

Over 7 days past: \$5.00 late fee will applied to your account.

*Weather Closings, Calendars, & Class Info. will all be located on BAND each class will have one.

*Attendance & Performance:

Waiting Rooms are closed until further notice.

Please arrive on time for pick-up and drop-off. Come to each class prepared. We reserve the right to deny participation in performances to students who have missed excessive classes or are not properly prepared. The last 4 classes, rehearsal, and BOTH recitals are MANDATORY for all performers! Recital Day for 2023 is April 29th with show times posted on BAND asap!

*Discipline:

Listening, participation, a good attitude, and respect of staff and property are expected at all times. NDS has a 3 strike policy for handling inappropriate or disruptive behavior. 1st warning a parent will be notified. 2nd warning the dancer will be asked to sit and watch the remainder of that class and parent will be notified. 3rd warning student will be removed from class. Parent will be notified to promptly pick them up, and the student will be asked to not return. NDS has a ZERO tolerance policy for violence and that student will be expelled immediately.

No refunds of any kind will be given for expulsion from NDS for these behaviors.

Class placement will be determined according to ability at the sole discretion of NDS. Students of different ages will be grouped together and groups may change each season. Dancers may need to be moved around to ensure proper placement
